## Bidding the Opponents Suit

Often known as an "Unassuming cue bid", this helps to reach your side's game or slam despite the interference. It is alertable and forcing for one round.

A new suit bid by partner probably shows first round control.

## **Directional Asking Bids**

After more exploration, these bids are used when the opponents have overcalled during the auction, often to find a No Trumps contract.

South's bid of 3. is a directional asking bid, a type of cue bid, recognisable because it is the opponents' suit. South seeks help from North in finding the best contract. It implies little support for either of North's suits, or a need for help in controlling clubs in a possible No Trumps contract. North's response of 3NT implies some control of the club suit, and therefore that 3NT is probably the best contract.
